

This LICENSE AGREEMENT (“License”) is entered into as of the Effective Date between Cost Data On Line, Inc., located at 6362 Rockmine Ct, Las Vegas, Nevada 89118 (“CDOL”) and you (“Licensee”), an entity accessing or using the Database (as defined below) specified in the applicable Sales Agreement (as defined below). Taken together, (a) this License, and (b) the applicable Sales Agreement, collectively are hereinafter referred to as the “Agreement” with respect to Licensee’s use of the Database.

The “Effective Date” of the Database is the date which is the effective date of the Sales Agreement. The Agreement governs use of the Database no matter how accessed, including without limitation via a mobile, tablet or web application. If the individual entering into the Agreement is an employee or agent of Licensee, then such individual must be authorized to, and by agreeing to the terms of the Agreement hereby does, bind Licensee to the Agreement.

Licensee and Trimble Inc., a Delaware corporation, and its affiliates (“Trimble”) may enter into orders, quotations, change orders, sales agreements, or any other document referencing this License (which may consist of online registration or separate Trimble order forms) (each, a “Sales Agreement”) for Licensee’s purchase of the Database from Trimble. The version of this License referenced in the Sales Agreement will govern Licensee’s purchase of the Database specified therein.

## **TERMS AND CONDITIONS**

### **1. GRANT OF LICENSE:**

- 1.1 CDOL hereby grants to Licensee, a non-exclusive, non-transferable and non-assignable License to use the Database (as defined in Section 1.4) and Derivatives as defined in (Section 1.5) subject to the terms and conditions of this License for the Subscription Period as defined in (Section 1.6) for Licensee’s own internal business purposes, and only on the Supported Computer(s) (as defined in Section 2.2) by employees of Licensee. The term Database applies whether the product was provided to the Licensee by CDOL directly or by a CDOL Authorized Partner (as defined in Section 2.1 below) and applies to any Derivative created by Licensee in the course of their own internal business process. Licensee shall not permit any other person or entity to access and use the Database. Licensee is not permitted to use the Database for on-line applications unless specified by CDOL in writing.
- 1.2 REVISIONS/UPDATES: The Database contains the current CDOL data. During Licensee’s subscription term, CDOL may periodically revise the information contained in the Database. Licensee may obtain revisions and updates directly from the software supplier.
- 1.3 RESTRICTIONS. The Database may not be used on a service bureau or time-sharing basis. Nothing in this license shall grant the LICENSEE the right to resell, loan, rent, sublicense, lease or sublease, donate or share the Database, Derivatives, Documentation or Products. The Licensee may not transfer or assign any copies of Database, Derivatives, and all Documentation on a permanent basis unless the Licensee receives prior, written approval from CDOL, and the transferee agrees to be bound by the terms of this License. Licensee shall retain no copies. Such transfer terminates Licensee’s license to use the Database.
- 1.4 “Database” shall mean CDOL’s proprietary electronic database in printed or machine readable form (including any accompanying Customized Documentation, Documentation, manuals, upgrades, releases, databases, enhancements and instructions whether in electronic or printed form) delivered to Licensee and any copies thereof pursuant to this License and/or listed below. Database shall also include any Derivative (as defined in Section 1.5) of the Database and third party software, Customized Documentation and Documentation (if any) delivered to Licensee by CDOL. “Documentation” shall mean an electronic copy of CDOL’s product or user documentation or manuals. “Customized Documentation” shall mean any Documentation that is used for the purpose of preparing unique and customized training documentation in connection with Licensee’s use of the Database and shall be also considered a Derivative.

Licensee shall initially purchase the number of [concurrent use] licenses (“Users”) solely for usage within Licensee’s business unit within Licensee’s organization (“Business Unit”) set forth in the Sales Agreement.

- 1.5 DERIVATIVES: The Licensee is granted the right to create Derivatives of the Database subject to the terms of this License. An "Estimate" is defined as any calculated work result that is directly derived from or generated from the Database or uses any portion of the Database during its creation either in printed form or in a machine-readable form. An Estimate is not a Derivative unless it is being used in an effort to circumvent the License or the Subscription. A Derivative is created when: (i) any portion of the Database is used to create a custom machine readable or printed form of the data. Derivatives are defined as results derived from the Database used to build or update an Estimate either as a reference or as a direct input to the Estimate and are the same as the Database. CDOL retains all right, title and interest to all Derivatives and any Derivative shall be subject to the terms of this License. Licensee may use and access the Estimates that are created by the Licensee as a data source so long as this License is in effect. Licensee may retain Estimates created using the supplied data for historical purposes. Any use of an Estimate as a data source to build a new Estimate without a valid License is considered a violation of this Agreement, the United States copyright laws and international treaty provisions.
- 1.6 DURATION OF LICENSE: The License granted hereunder commences on Effective Date and shall expire on the date specified in the Sales Agreement (the "Initial Term") for each Database product licensed. Prior to the expiration of the License granted hereunder, but in no event less than sixty (60) days prior to the expiration date of the Initial Term or any Renewal Term, Licensee shall provide CDOL with notice that Licensee intends to renew the License for an additional year (each a "Renewal Term"). Provided that Licensee pays CDOL its then-current fee for such a renewal, CDOL shall renew the License granted hereunder for an additional one-year period by amending the term of the License in writing and all other terms and conditions herein shall apply. For purposes of this License, the Initial Term and any Renewal Terms may be referred to collectively as the "Subscription Period." Licensee agrees that failure to renew this License as stated in this Section constitutes the Termination of License and is subject to the conditions set forth in Section 1.7.
- 1.7 TERMINATION OF LICENSE: CDOL may terminate this Agreement for its convenience by providing Licensee with thirty (30) days prior written notice. CDOL may immediately terminate this License if the Licensee materially breaches its obligations under this License. Upon expiration or termination of the License, Licensee's right to use the Database, Documentation, Customized Documentation, Derivatives, and CDOL Proprietary Information licensed hereunder shall end and Licensee shall: (i) promptly return the Database, Documentation, Customized Documentation, Derivatives, and CDOL Proprietary Information and all copies thereof to CDOL; (ii) erase the Database, Derivatives, Documentation, Customized Documentation, and CDOL Proprietary Information and all copies from the memory of its computer(s) and storage devices or render it non-readable; and (iii) upon CDOL's request, certify in writing that Licensee has satisfied its obligations hereunder.

## **2. LICENSEE:**

- 2.1. May deploy the Database using the same model as the "Hosting Software" which is defined as the software provided by the CDOL Authorized Partner. A "CDOL Authorized Partner" is an entity that has a current, effective partner or reseller agreement with CDOL. CDOL further grants the CDOL Authorized Partner the right to provide additional services utilizing the Database. The work results of the CDOL Authorized Partner services are subject to Section 1.5 when applicable. The number of Concurrent Users of the Database allowed to access the database is stated in Section 1.4.
- 2.2. May, subject to the terms of this License, transfer or move the Database from one Supported Computer to another Supported Computer (as defined below) strictly within Licensee's designated Business Unit (set forth in Section 1.4) at any time as long as such efforts do not violate the terms of this License. A "Supported Computer" as used in this Section 2.2 shall mean one or more computers owned or leased by Licensee under Licensee's control, of a

manufacturer, model and operating system for which CDOL offers a current version of the Database.

- 2.3. May make one (1) copy of the Database solely for back-up, archival purposes; provided that, CDOL's copyright and proprietary notices on the Database are included on such copy.
- 2.4. Shall treat the Database and/or Derivatives like any other copyrighted material (e.g., a book or musical recording). The Database and/or Derivatives is owned by CDOL and is protected by United States copyright laws and international treaty provisions
- 2.5. Shall not use, copy, modify, or transfer the Database except as expressly provided in this License.
- 2.6. Shall not reverse compile, disassemble or otherwise reverse engineer the Database. In the event Licensee requires modifications to the Database to make it inter-operable with other Hosting Software, CDOL shall, at its option, (i) make the Database inter-operable with such other Database, (ii) provide Licensee with the tools and information necessary to make the Database inter-operable, or (iii) grant Licensee the right to make such modifications, provided that such activities are limited to the minimum extent required for the Database's intended use and are only performed to the minimum extent required by law. Any end work results of such activities are subject to Section 1.5.
- 2.7. Protect Intellectual Property of CDOL. All information or data supplied by CDOL in printed or machine-readable form are the Intellectual Property of CDOL. The Licensee acknowledges that the continued integrity of the Database and CDOL's performance of its obligations described in this License are dependent upon the proper use and maintenance of the Database by Licensee. Proper use and maintenance means that Licensee will (i) install all upgrades and releases delivered to Licensee hereunder, (ii) use the Database in accordance with the Documentation supplied by CDOL Authorized Partner and the terms and conditions of this License and (iii) follow CDOL Authorized Partner instructions for installing new releases and for correcting and circumventing bugs.
- 3. OWNERSHIP AND PROPRIETARY RIGHTS:** This Database and printed materials are proprietary products of CDOL, Inc., and are protected by U.S. copyright law (Title 17 United States Code) and international treaty. Unauthorized reproduction and/or sales may result in imprisonment of up to one year and fines of up to \$100,000 (17 USC 506). Copyright infringers may also be subject to civil liability. The Database, including, without limitation, Derivatives, is owned by CDOL. Licensee agrees that the Database and use and disclosure must be carefully and continuously controlled. Licensee further agrees that certain underlying algorithms, processes, and methods of operation, are the Intellectual Property of CDOL. CDOL retains title to the Database, Derivatives, Documentation, Customized Documentation, data or any other information furnished by CDOL directly or an CDOL Authorized Partner to Licensee. Licensee agrees not to remove or destroy any proprietary markings or proprietary legends placed upon or contained within the Database or any related materials or Documentation and Customized Documentation. Licensee retains title to all Estimates created by Licensee as long as Estimates meet the terms of this License.
- 4. CONFIDENTIALITY:** CDOL may furnish Licensee with CDOL's trade secrets, confidential and proprietary information ("Proprietary Information") in connection with the provision of Database and support. Licensee shall protect such Proprietary Information to the same degree it protects its own proprietary information, but with no less than a reasonable degree of care. The Database licensed hereunder shall also be considered Proprietary Information and, except as specifically permitted herein, shall not be disclosed to any third party.
- 5. WARRANTY:**
  - 5.1. AS-IS WARRANTY/LIMITATION OF REMEDIES. CDOL DOES NOT WARRANT AND EXPRESSLY DISCLAIMS ANY LIABILITY FOR THE RELIABILITY OR ACCURACY OF THE DATA CONTAINED IN THE DATABASE. LICENSEE EXPRESSLY AGREES THAT USE OF THE DATABASE ARE AT LICENSEE'S SOLE RISK. THE DATABASE IS PROVIDED ON AN

“AS IS”, “AS AVAILABLE” BASIS WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT. CDOL MAKES NO WARRANTY THAT (i) THE RESULTS THAT MAY BE OBTAINED FROM THE USE OF THE DATABASE WILL BE ACCURATE OR RELIABLE, (ii) THE QUALITY OF ANY PRODUCTS, SERVICES, INFORMATION, OR OTHER MATERIAL PURCHASED OR OBTAINED BY LICENSEE THROUGH THE DATABASE WILL MEET CUSTOMER’S EXPECTATIONS, OR (iii) ANY ERRORS IN THE DATABASE OR DOCUMENTATION WILL BE CORRECTED.

- 6. PATENT AND COPYRIGHT INDEMNIFICATION:** CDOL will defend, at its expense, any action brought against Licensee or Licensee’s use thereof in accordance with this License to the extent that it is based on a claim that the unmodified Database supplied to Licensee constitute direct infringement of any third party’s intellectual property right based on US law up to the amount of fees paid by Licensee under this License, provided that CDOL is: (i) informed in writing within seven (7) days of Licensee becoming aware of same in writing and furnished a copy of each communication, notice, or other action related to the alleged infringement; (ii) is given full control, authority, information, and assistance necessary to defend or settle such claim; and (iii) Licensee fully cooperates with CDOL in any defense or settlement of such claims. CDOL will not be obligated to defend or be liable for costs and damages if the infringement arises solely out of compliance with the Licensee’s specification, or from a combination with or an addition to programs not developed and supplied by CDOL or its distributor or modification of the Database after delivery by CDOL or its distributor. In the event any Database furnished hereunder is, in CDOL’s opinion, likely to, or does, become the subject of a claim of infringement of third party’s intellectual property right based on US law, Licensee’s sole and exclusive remedy shall be that CDOL will, in its sole discretion: (i) procure for Licensee the right to continue using the Database; (ii) modify the Database to make them non-infringing; or (iii) replace them with non-infringing Database, which may, at CDOL’s option, come under this same License. THE FOREGOING STATES THE ENTIRE LIABILITY OF CDOL WITH RESPECT TO INFRINGEMENT OF ANY COPYRIGHTS, PATENTS, OR OTHER INTELLECTUAL PROPERTY RIGHTS BY THE DATABASE OR ANY PARTS THEREOF AND IS IN LIEU OF ALL WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED.
- 7. DELIVERY AND INSTALLATION:** Database will be delivered by CDOL Authorized Partner at FCA CDOL Authorized Partner’s warehouse except as otherwise agreed to in writing. Licensee understands and agrees that it shall be primarily responsible for the installation of the Database.
- 8. ACCEPTANCE:** Licensee agrees that the Database shall be deemed delivered and accepted upon shipment.
- 9. GENERAL:**
  - 9.1 This License shall not be assigned or transferred by Licensee without the prior written consent of CDOL and so long as the assignee agrees to the terms and conditions and signs the current version of the CDOL License Agreement provided by CDOL. Assignment of this License pursuant to this provision shall not be an assignment to the transferee of any maintenance rights associated with such License except as agreed to in writing by CDOL. Unless otherwise agreed to by CDOL in writing, Licensee shall remain liable for all obligations under this License or any related maintenance agreement related to any assigned license and maintenance rights, including, without limitation, the payment of any outstanding fees due to CDOL.
  - 9.2 If any provision of this License shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this License and the remaining provisions shall be given full force and effect to the extent not inconsistent with the original terms of this License.
  - 9.3 The parties agree that no action, regardless of form, arising hereunder, may be instituted by either party more than one (1) year after the cause of action arose or such party became aware of the cause of action.
  - 9.4 It is agreed that this License shall be governed by and construed in accordance with the laws of

the State of Texas, without regard to its conflicts of laws provisions. Any and all legal actions must be brought in the courts in the State of Nevada or State of Texas.

- 9.5 The obligations set forth in Sections 3, 4, 9, 10, 11, and 12 shall survive termination or expiration of the license granted pursuant to this License.

#### **10. U.S. GOVERNMENT RESTRICTED RIGHTS:**

- 10.1 The Database and accompanying materials are provided with restricted rights.
- 10.2 The Database is subject to the following Restricted Rights Legend: "Use, duplication or disclosure by the Government is subject to restrictions as set forth in (i) FAR 52.227-14, Alt. III, (ii) FAR 52.227-19, (iii) DFARS 252.227-7013©(1)(ii), or (iv) the accompanying license agreement as applicable. For purposes of the FAR, this Database shall be deemed to be "unpublished" and licensed with disclosure prohibitions. (If Licensee is acquiring necessary and applicable restricted rights legends on the Database and the documentation to protect CDOL's proprietary rights under the FAR or other similar regulations of other federal agencies, the Licensee agrees to always include such legends whenever the Database is, or is deemed to be, a deliverable under that contract.) Contractor/Manufacturer is CDOL, Inc., P.O. Box 531477, Henderson, NV 89053.

#### **11. LIMITATION OF LIABILITY:**

- 11.1 In no event shall CDOL be liable to Licensee or any party claiming through Licensee for any damages or expenses of any type, including, but not limited to, any lost profits, lost savings, loss of use, loss of data, lost business, loss of anticipated benefits, or other incidental or consequential damages, direct or indirect, special or general, arising out of the use or inability to use such Database whether arising out of contract, negligence, tort, or under any warranty, or otherwise, and whether caused by defect, negligence, breach of warranty, delay in delivery, or otherwise, even if CDOL has been advised of the possibility of such damages or for any other claim by any other party.
- 11.2 Limitation of liability. In no event shall CDOL be liable to the Licensee for any damages, claims, or any other claim, whether in tort, contract, negligence, or otherwise arising more than one (1) year prior to institution of a legal proceeding thereon. In no event shall CDOL's liability with respect to a specific database license exceed the amount of license fees paid by Licensee under such license.
- 11.3 Third party suppliers. Certain portions of the Database licensed hereunder contain functionality supplied by third parties. In no event shall such third parties, including CDOL's third party developers, vendors, suppliers, contractors, or consultants, be liable for any direct, indirect, special, incidental or consequential damages arising from this License. Such third parties are beneficiaries of the license of such database granted to Licensee hereunder. Third party database components in the CDOL database or otherwise supplied by CDOL may not be used independently of the CDOL database.

- 12. EXPORT:** To Licensor's knowledge, Licensor certifies that the Database is classified as EAR99 under the Export Administration Regulations (EAR) codified at 15 Code of Federal Regulations, Chapter 7, which can be found at the US Bureau of Industry and Security (BIS) web site <http://www.bis.doc.gov/>. Licensee agrees that the Database will not be used or distributed in a way that would be noncompliant with the EAR. If the Database, when used with the Trimble software is classified other than EAR 99 under the Export Administration Regulations (EAR) codified at 15 Code of Federal Regulations, Chapter 7, then, notwithstanding any other provision of this License, Licensee shall, at Licensee's sole discretion, stop using the Database. Licensee represents and warrants that the Database shall not be used for any nuclear-/chemical/biological warfare, missile end-use or training related thereto. Licensee also agrees that it will not, without first procuring a BIS license or License Exception, re-export or release the above software to a national of a country in Country Code E:1 or E:2 other than individuals lawfully employed in the United States by Licensee who are not listed on any of the lists included in the Consolidated Screening List (CSL) maintained by the Department of Commerce.

**13. NOTICES.** All notices pursuant to this License shall be in writing and sent certified mail, return receipt requested, addressed as follows. Changes to the notification address information must be sent in writing and shall only become effective upon receipt of written notification from the party initiating the change.

**14. FORCE MAJEURE.** Either party's failure to perform its obligations hereunder shall not be deemed a breach of this License if such failure is due to fire, strike, war, civil unrest, terrorist action, government regulations, acts of nature, or other causes beyond the reasonable control of the party claiming force majeure. This provision shall not apply to Licensee's obligation to pay any sums due under this License, which shall continue unabated.

**15. PUBLICITY.** In consideration of the license(s) granted hereunder, CDOL may (a) identify Licensee in published lists of licensees of the CDOL Database, (b) issue press releases announcing general details of Licensee's relationship with CDOL under this License, and (c) describe Licensee's successful use of the Database in published articles. Licensee may, upon request, review such materials in advance of publication.

**16. INTEGRATION.** LICENSEE ACKNOWLEDGES THAT LICENSEE HAS READ THIS LICENSE, WHICH INCLUDES ALL ADDENDUMS, UNDERSTANDS EACH AND EVERY TERM AND CONDITION, AND AGREES TO BE BOUND BY ITS TERMS AND CONDITIONS. LICENSEE AGREES THAT THIS LICENSE IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE LICENSE BETWEEN CDOL AND LICENSEE FOR THE DATABASE, THE DOCUMENTATION AND THE CUSTOMIZED DOCUMENTATION. LICENSEE AGREES THAT THIS LICENSE SUPERSEDES ALL PRIOR AND CONTEMPORANEOUS, PROPOSALS, NEGOTIATIONS, OR DISCUSSIONS, ORAL OR WRITTEN, RELATING TO THE SUBJECT MATTER HEREIN. LICENSEE ACKNOWLEDGES AND AGREES THAT THE TERMS OF THIS LICENSE INCLUDING, WITHOUT LIMITATION, ANY PROVISIONS RELATING TO WARRANTIES, PREVAIL OVER ANY LICENSES CONTAINED IN THE DATABASE PACKAGE AND USER DOCUMENTATION DELIVERED TO LICENSEE PURSUANT TO THIS LICENSE. ANY ADDITIONAL OR CONFLICTING PROVISIONS CONTAINED IN LICENSEE'S PURCHASE ORDER SHALL NOT APPLY.
